1. These hunts are semi-guided with 3-1 client to guide ratio unless otherwise arranged in writing. You will be hunting on Private and/or National Forest land depending on your hunting license for unit 521. Client may not transfer or resell this hunt or other rights hereunder without written permission from BCO

2. Bear Creek Outfitters LLC ("BCO") will provide the following: Lodging, food, transportation on BCO properties and one guide for every three clients. **BCO does not provide: sleeping bags, personal gear, weapons, hunting licenses, meat storage or processing.**

### 3. The Client Agrees to:

A. Pay all deposits and fees when due and furnish all required information by the dates promised. While on property and/or national forest land abide by all State and Federal laws and regulations, U.S. Forest Service regulations, and camp and other rules as provided by BCO.

B. Purchase applicable license(s) **and have licenses(s) in possession at all times.** If born after January 1, 1949, **have in possession a Hunter Safety Card at all times.**

C. The Client shall arrange for their own transportation to and from BCO properties unless otherwise contracted.

D. Bring sufficient but not excessive amounts of personal gear based upon the list provided by the outfitter

E. **Clients must state age, height, weight, and medical conditions.**

F. Client recognizes the risks of hunting generally, firearm or archery equipment use, hunting at high altitude and will insure his or her own physical health is up to the demands of a hunting trip at high altitude. Client hereby releases BCO, its members, managers, officers, employees, guides and agents from any and all liability, damages, claims, losses, demands or injury associated with Client's hunting trip, equipment use, hunting in general the physical activities involved therein, or any other activity on BCO properties, including without limitations the rules and hunt termination rights of BCO set forth in section 5 below. Client acknowledges and agrees that they will need to sign a BCO waiver form prior to hunting or activities on BCO property.

### 4. Fees and conditions:

A. In consideration of the BCO providing the services and/or accommodations set forth herein (including in any attachment hereto), the **Client hereby agrees to pay BCO the sum of \$ \_\_\_\_\_ per hunter ("Fee"). The Fee does not include gratuities for hunting guides or camp chef nor charges for additional services.** The Fee includes the taking of one elk per Client (no group hunting). Any additional elk or other game species (deer, bear, etc.) taken is half price per animal upon arrival.

B. Upon execution of this Hunting Contract ("Contract") by Client, Client hereby agrees to pay to BCO within 14 days a non-refundable deposit of 50% of the above amount (Non-refundable Deposit) . In the event such Non-refundable Deposit is not received by BCO within this 14 day period, this Contract and any other written or oral Contracts between BCO and Client will be null and void and in no way binding to BCO, unless otherwise agreed in writing by BCO, and BCO shall have no further liability to Client

C. The balance of the Fee shall be paid by Client on or before arrival at the BCO properties for the scheduled activities.

**5. Cancellations and refunds and Hunt termination:**

A. The Non-Refundable Deposit shall be paid to BCO and applied against the total Fee. If Client does not deliver the remainder of the fee to BCO by the hunt date set forth in this Contract, Client's scheduled hunt will be cancelled by BCO and BCO shall be entitled to keep the Non-Refundable Deposit and sell the Hunt to another party without any liability to Client.

B. If the Client fails to draw the required license for the species under which this contract has been negotiated, the appropriate portion of the Non-Refundable Deposit will be returned to Client within 30 days of BCO's receipt of Client's notification that Client was not successful in the drawing.

C. Client understands and agrees that notwithstanding any other provisions of this Contract, BCO may, in its sole discretion, return any Non-Refundable Deposit or other amounts paid and decline to accept client for any or no reason, at any time without further liability to Client.

D. Client hereby agrees that BCO staff members have the sole and absolute discretion to terminate a hunt if (i) Client is unfit to continue their hunt due to skill level, physical fitness, safety, ethical or legal issues or any violation of internal or external BCO boundaries set for their group, (see map page 3) without refund or liability to Client

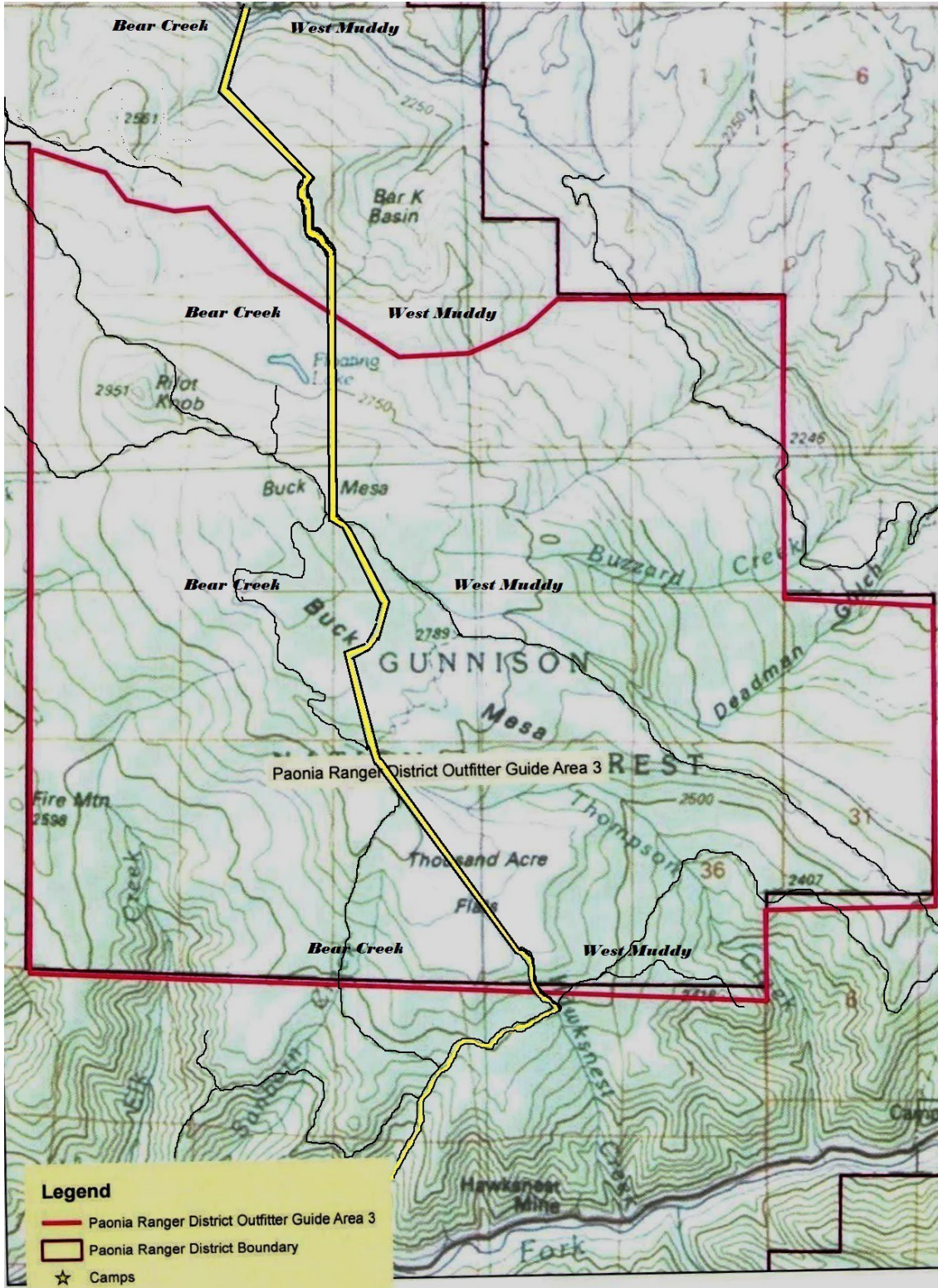
